#### Your first year at St Peter's College

An academic year at Oxford is divided into three terms. Over your first two terms at St Peter's College, you will study three subjects in preparation for the Law Moderation Exams (or 'Mods'), which will take place at the end of the second term (i.e. in March 2026). In Michaelmas Term (the first term), you will have tutorials in Criminal Law and Roman Law. In Hilary Term (the second term), you will have the remaining tutorials in Roman Law and study Constitutional Law. In addition to these college-based tutorials, there will be lectures organised by the Law Faculty. They will take place in person in the Law Faculty building. You will be provided more information about the lectures when you arrive at St Peter's. Around that time, you will also be contacted by your Criminal Law and Roman Law tutors and sent your tutorial reading lists. Please be mindful of the fact that your first essay submission deadline may be in the first week of term, that is within a week or so of your arrival in Oxford. You should do the best you can in these assignments but remember that students usually get familiar with writing an essay only over the course of the first term.

We hope that you are excited to start your Law studies at St Peter's and look forward to welcoming you in person in October.
